2009 Congressional Voting Record Inside

HOPE IS NOT ENOUGH; CONGRESS MUST DO MORE

AS THE OBAMA Administration began, our nation faced the most difficult economic environment since the Great Depression. What the media nicknamed "The Great Recession" was a combination of high job loss, long term unemployment, widespread public anger aimed at Wall Street, falling wages, a credit crunch, falling real estate prices, and millions of citizens without health care. It was a tsunami of economic challenges that cried out for bold and dramatic economic solutions.

While there were clear analogies between the Roosevelt Administrations reaction to the Great Depression and the Obama Administration's reaction to the Great Recession, there were also clear differences. A clear strategy emerged on the part of Republicans in both the House and the Senate to oppose rather than cooperate with the new Democratic President. In the 40 House and Senate votes that ADA counted in 2009, there were 12 votes when every Republican voted in a block in opposition – 6 in the House and 6 in the Senate. In 2008, there were only 4 such votes in the House and 3 in the Senate.

This is an indicator of the growing political divide in the country. Whatever the cause of the divide –and there is disagreement about this as well - it is clear is that the divide has inspired heated rhetoric that has included racial epithets, slurs regarding sexual orientation, spitting on Members of Congress, and threats of violence. The inability to discuss, debate and disagree with a modicum of decorum is a troubling sign, and unfortunately, linked to those who refer to themselves as Teabaggers.

The First Session of the 111th Congress shall be remembered by liberals for our hopes, for our achievements, for the deadlocks and for the challenges which remain. The session began with the swearing in of 256 Democratic Members of the House and 55 Democratic Members of the Senate (in addition to two Independent Senators who caucused with the Democrats); the highest percentages since the 1992 election for Democrats and the lowest for Republicans with 177 Republican House Members and 41 Republican Senators (41).

The rules of the Senate, however, give additional strength to the Minority Party as long as it can muster 41 votes to sustain or threaten filibusters which ensure its ability to grind the legislative process to a halt and can stop legislation, nominations, and government funding. The 110th Congress saw a record number of filibuster votes as the newly elected Democratic majority sought on-the-record votes on important issues that had been bottled up under Republican leadership.

However, this also empowers blocs among the Democrats as well. As we saw with health care, public threats to withhold their votes for the public option from Senators Lincoln (D-AR) and Lieberman (I-CT) helped to scuttle the effort as soon as it began. When you need 60 votes, every Democrat has the ability stop progress, and has made some Democratic Senators as much a challenge as the Republican minority.

As with each session of Congress - but in particular in this session - ADA board and staff struggled to present the most accurate picture of the positions of Members of Congress. Often the most illuminating actions and statements by Members of Congress do not make it to a vote. For example, the Employee Free Choice Act which strengthens workplace democracy and worker justice garnered significant and brave supports but did not come to a vote in the House or Senate this session largely because of Senate rules described above. So, while we continue to only count votes to determine voting records, we will

also consider cosponsorship and public positions with regards to endorsements and support. To do less would be to be held hostage to a Congressional process which can conceal positions and provide no real information with regard to important issues.

The Congressional snapshot shows that the liberal score dropped slightly for

Democrats. The average score of 89% in the House in 2008 dipped to 85% in 2009, while the Senate score ticked up from an average score of 90% in 2008 to an average score of 95% in 2009. The Republican average score became more conservative, dropping from an average of 22% in the House in 2008 to 7% in 2009, while the Senate score dipped from an average of 20% to 14%.

Other interesting trends existed for Heroes (100%), Zeroes (0%), and Moderates (40-60%). While Heroes and Zeroes in the Senate largely remained the same from 2008 to 2009 the House saw dramatic increases in both moving the Hero ranks from 59 to 95 and the Zero ranks from 16 to 75. Moderate scores dropped sharply in this environment as well as 40 House moderates became 20 and 8 Senate

moderates became 1 from 2008-2009.

As we move through 2010 and the Second Session of the 111th Congress, we will face election-year pressures from various forces. While we might hope that there will be a coming together to address the issues that confront the country, nothing in our recent history leads us to expect that result. Stark division between those we are describing as the “Hopeful Obama Democrats” and the “Fearful Republican Teabaggers” is reflected in both the nation, and among their elected representatives. Our hope is that the Congressional majority will make its will known and enact legislation consistent with their principals. There are always electoral consequences – both for action as well as for inaction. We urge the Congress to act; boldly, proudly and in the progressive tradition of Franklin D. Roosevelt. It is what the nation needs now, as before.

HOUSE VOTE DESCRIPTIONS

1. HR 12. Paycheck Equality/Passage.

Passage of the bill that would require employers to ensure that wage disparities are job-related and required by a business necessity. It would bar retaliation by employers against employees who share salary information with their co-workers, and provides for compensatory and punitive damages for discrimination cases. Passed 256-163: Jan. 9, 2009. A yes vote is a +.

2. HR 384. Troubled Asset Relief Program/

Passage. Sets conditions on the use of the second \$350 billion provided under the 2008 financial industry bailout law. It would require the Treasury Dept. to use Troubled Asset Relief Program (TARP) funds for foreclosure mitigation, to provide assistance to domestic automobile manufacturers, and to ensure that executive-compensation restrictions could be applied to all firms that received assistance. Passed 260-166: Jan. 21, 2009. A yes vote is a +.

3. HR 1. Economic Stimulus/Passage.

Passage of the bill that would provide \$819.5 billion in tax cuts and spending through fiscal 2019 to stimulate the economy, including upgrades to transportation, infrastructure, construction, health care programs, education and housing assistance, and energy efficiency projects. The bill also includes \$274.6 billion in tax benefits for individuals and businesses. Passed 244-188: Jan. 28, 2009. A yes vote is a +.

4. HR 2. Children's Health Insurance/

Passage. Waxman, D-Calif., motion to concur with the Senate amendment to reauthorize the State Children's Health Insurance Program (SCHIP). It would offset the cost of the expansion by increasing the federal tax on cigarettes, it would remove the five-year waiting period for new, legal immigrants, including pregnant women, to sign up for SCHIP. The bill would limit program eligibility to families earning three times the federal poverty level or less and would require states to phase out coverage of childless adults. Motion agreed to, 290-135: Feb. 4, 2009. A yes vote is a +.

5. HR 1106. Mortgage Loans Modification/

Passage. Passage of the bill that would allow bankruptcy judges to reduce the principal and interest rates of loans for individuals whose mortgages are larger than the value of their homes or who meet other requirements. It would allow for governmental reimbursement lenders for principal, interest or fees if the mortgage was guaranteed by certain Federal guarantors. It also would modify the Hope for Homeowners program and would permanently increase, to \$250,000, deposit insurance coverage on individual bank accounts, and index them to inflation beginning in 2015. Passed 234-191: Mar. 5, 2009. A yes vote is a +.

6. HR 1388. National Service Programs/

Motion to Concur. Miller, D-Calif., motion to concur in the Senate amendments to reauthorize the Corporation for National and Community Service programs, increase the education award for full-time service volunteers, and increase the award for Pell grants. It also would bar participants from engaging in certain activities, such as lobbying or providing abortion services or referrals, as part of their program duties. Motion agreed to, 275-149: Mar. 31, 2009. A yes vote is a +.

7. HR 1664. Executive Compensation

Standards/Passage. Passage of the bill that would prohibit firms that received funds under the Troubled Asset Relief Program, as well as certain Federal Agencies, from paying compensation deemed excessive by the Treasury, with certain exceptions. The institutions would be required to report to the department on the number of employees who receive compensation of more than \$500,000, \$1 million, \$2 million, \$3 million and \$5 million. The restrictions would be lifted when an institution repays the borrowed funds. Passed 247-171: Apr. 1, 2009. A yes vote is a +.

8. S Con Res 13. Fiscal 2010 Budget

Resolution/Conference Report. Adoption of conference report on the budget resolution that would fund up to \$1.086 trillion in non-

emergency discretionary spending for fiscal 2010, \$764 billion in tax cuts, including \$130 billion for Iraq. An expected \$2 billion in savings, presumably from health care and student loan programs, will be used to create a deficit-neutral reserve fund for health care and climate change legislation. Adopted (thus sent to the Senate), 233-193: Apr. 29, 2009. A yes vote is a +.

9. HR 1913. Hate Crimes Prosecution/

Passage Passage of the bill that would expand federal hate crimes law to cover those based on sexual orientation, gender or disability. The bill would authorize funds in fiscal 2010 and 2011 for grants to law enforcement agencies to investigate and prosecute hate crimes, and funds through 2012 for additional Justice Department personnel to address hate crimes. Passed 249-175: Apr. 29, 2009. A no vote is a +.

10. HR 626. Federal Employee Paid

Parental Leave/Passage. Legislation that would grant federal employees paid leave for up to four weeks to care for newborn, newly adopted or foster children. Employees could use accrued annual or sick leave for parental leave. Passed 258-154: Jun. 4, 2009. A yes vote is a +.

11. HR 2847. Fiscal 2010 Commerce-

Justice-Science Appropriations/Closure of Guantánamo Bay Prison. Lewis, R-Calif., amendment that would bar the use of funds in the bill to close the detention facility at Guantánamo Bay, Cuba. Rejected. 212-216: Jun. 18, 2009. A no vote is a +.

12. HR 2454. Greenhouse Gas Emissions/

Passage. Passage of the bill that would create a cap-and-trade system to limit greenhouse gas emissions and set new requirements for electric utilities. The bill would set emissions limits at 17 percent below current levels in 2020, expanding to 83 percent in 2050, and require utilities to produce 15 percent of the nation's electricity from renewable sources by 2020. It would establish programs to assist energy consumers with higher utility bills resulting from the new system. Passed 219-212: Jun.

13. HR 3170. Fiscal 2010 Financial Services Appropriations/Passage. Passage of the bill that would provide \$46.2 billion in fiscal 2010 for the Treasury Department, the Office of Personnel Management, the District of Columbia and other agencies. Passed 219-208: Jul. 16, 2009. A yes vote is a +.

14. HR 3435. Car Voucher Program Funding/Passage. Obey, D-Wis., motion to suspend the rules and pass the bill that would provide \$2 billion for the “Cash for Clunkers” vehicle trade-in program, which offers vouchers worth up to \$4,500 toward the purchase of new vehicles when traded for older, less-efficient models. The funds would be transferred from the Energy Department’s innovative-technologies loan guarantee program. Motion agreed to 316-109: Jul. 31, 2009. A yes vote is a +.

15. HR 2647. Fiscal 2010 Defense Authorization/Conference Report. Adoption of the conference report on the bill that would authorize \$680.2 billion in discretionary spending for defense programs in fiscal 2010, including approximately \$130 billion for the wars in Iraq and Afghanistan and other operations. It would authorize a 3.4 percent pay raise for military personnel, would prohibit detainees at Guantánamo Bay, Cuba, from being transferred to U.S. soil until the President submits a plan to Congress and would extend federal hate crimes laws to cover offenses motivated by a victim’s gender identity, sexual orientation or disability. Adopted (thus sent to the Senate) 281-146: Oct. 8, 2009. A yes vote is a +.

16. HR 2868. Chemical Plant Security/Passage. Passage of the bill that would authorize \$900 million in fiscal 2011 through 2013 for the Department of Homeland Security to conduct assessments and codify security standards for chemical plants. It would direct the agency to identify chemical plants according to a risk-based tier system and require plant operators to submit site

security plans. It would also authorize the EPA to regulate the security of community water systems that present a security risk, and would authorize \$315 million in fiscal 2011 for grants to states and nonprofits to help develop security plans for covered public water systems. Passed 230-193: Nov. 6, 2009. A yes vote is a +.

17. HR 3962. Health Care Overhaul/Abortion Funding Ban. Stupak, D-Mich., amendment that would bar the use of federal funds to pay for abortion or to cover any part of the costs of any health plan that includes abortion coverage, unless the pregnancy is the result of rape or incest or would endanger the woman’s life. Individuals with subsidized policies who also want abortion coverage would have to purchase it separately, without federal assistance. Adopted 240-194: Nov. 7, 2009. A no vote is a +.

18. HR 3962. Health Care Overhaul/Passage. Passage of the bill that would overhaul the nation’s health insurance system and require most individuals to buy health insurance by 2014. It would create an agency tasked with establishing a federal health insurance exchange, including a government-run “public option,” to allow individuals without coverage to purchase insurance. Those who do not obtain coverage would be subject to an excise tax, with hardship waivers. Employers would be required to offer health insurance or contribute to a fund for coverage; non-compliance could bring penalties of up to 8 percent of their payrolls. It would provide tax credits to certain small businesses for providing coverage and provide subsidies to individuals making up to four times the federal poverty level, excluding illegal immigrants. The bill would bar the use of federal funds to provide abortions, except in cases of rape or incest or if the woman’s life is in danger. Insurance companies could not deny or reduce coverage based on pre-existing medical conditions. Passed 220-215: Nov. 7, 2009. A yes vote is a +.

19. HR 4173. Financial Industry Regulation Overhaul/Passage. Passage

of the bill that would overhaul federal regulation of the financial services industry. It would establish a process for dissolving failing financial institutions that pose risks to the financial system and create a Consumer Financial Protection Agency. It would regulate the financial derivatives market, require registration of all credit rating firms, strengthen investor protections and require a registry of private capital investment advisers. As amended, the bill would set national mortgage standards, allow the Office of the Comptroller of the Currency to overrule state consumer finance laws if they impair national bank business and authorize the use of \$4 billion of Troubled Asset Relief Program funds for housing relief. Passed 223-202: Dec. 11, 2009. A yes vote is a +.

20. HR 2847. Jobs Funding and Year-End Extensions/Motion to Concur. Obey, D-Wis., motion to concur in the Senate amendment to the bill with a House amendment that would appropriate \$154.4 billion for infrastructure projects, jobs programs, and aid to state and local governments. It would redirect \$75 billion of the money from the Troubled Asset Relief Program, with \$48.3 billion for infrastructure projects and \$26.7 billion for aid to help state and local governments preserve public jobs. It also would extend unemployment benefits, COBRA health care premium subsidies and provisions requiring the federal government to assume an increased share of Medicaid funding through June 30, 2010. Motion agreed to 217-212: Dec. 16, 2009. A yes vote is a +.

1. S 181. Wage Discrimination/Passage.

Legislation that would amend the 1964 Civil Rights Act to clarify time limits for workers to file employment discrimination lawsuits, and allow workers who allege discrimination to file charges of pay discrimination. The bill would renew the statute of limitations with each act of discrimination. Passed 61-36: Jan. 22, 2009. A yes vote is a +.

2. HR 2. Children's Health Insurance / "Mexico City Policy."

Amendment that would have reinstated the so-called "Mexico City" policy, which bars U.S. aid to international family planning organizations that perform or promote abortion, even with their own funds. Rejected 37-60: Jan. 28, 2009. A no vote is a +.

3. HR 2. Children's Health Insurance/ Passage.

Passage of the bill that would reauthorize the State Children's Health Insurance Program, increase funding by increasing the federal tax on cigarettes and other tobacco products, removing the waiting period for new, legal immigrants, including pregnant women, and modify requirements for eligibility. The bill would limit program eligibility to families earning three times the federal poverty level or less and would require states to phase out coverage of childless adults. Passed 66-32: Jan. 29, 2009. A yes vote is a +.

4. HR 1. Economic Stimulus/Cloture.

Motion to invoke cloture (thus limiting debate) on the amendment that would provide approximately \$838 billion in tax cuts and additional spending to stimulate the economy, provide funds for a state fiscal relief and tax relief to seniors, disabled veterans and those who receive disability payments. It would also increase existing unemployment benefits, provide an additional benefits, expand the homeownership tax credit and temporarily increase federal Medicaid matching funds. Motion agreed to 61-36: Feb. 9, 2009. A yes vote is a +.

5. HR 1. Economic Stimulus/Passage.

Final passage of the Economic Stimulus Bill providing \$838 billion in tax cuts and additional spending to stimulate the economy, including a provision to exempt additional taxpayers from paying the alternative minimum tax in 2009. It would provide funds for a state fiscal stabilization fund and a one-time payment to seniors, disabled veterans and those who receive disability payments. The bill would expand bonus depreciation for 2009, increase weekly unemployment benefits and provide an additional 20 weeks of unemployment benefits (an additional 33 weeks in states with high unemployment rates). It would suspend federal income tax on the first \$2,400 of unemployment benefits for 2009. It also would expand the current homeownership tax credit by up to \$15,000 and allow the credit for purchases of a primary residence. It would temporarily increase federal Medicaid matching payments for states by an estimated \$87 billion. Passed 61-37: Feb. 10, 2009. A yes vote is a +.

6. S 160. District of Columbia Voting Rights/Passage.

Passage of the bill that would add two seats to the House of Representatives, expanding its membership to 437. It would add a seat for the D.C. and provide an extra seat for Utah in the 112th Congress. D.C.'s seat would be permanent; beginning with the 113th Congress, the second seat would be apportioned based on 2010 census figures. The Electoral College would be modified to accommodate the change. It also would repeal a number of DC gun restrictions. Passed 61-37: Feb. 26, 2009. A yes vote is a +.

7. HR 1388. National Service Programs/ Passage.

Legislation that would reauthorize Corporation for National and Community Service programs, increase the education reward for full-time service volunteers, and increase the accompanying Pell grant. Volunteers older than 55 could transfer the education reward to a child or grandchild. It would fund AmeriCorps, Volunteers in Service to America Program, Learn and Serve America, Retired and Senior

Volunteer Program, Foster Grandparent Program, and the Senior Companion Program. Activities such as lobbying or providing abortion services or referrals would be prohibited. Passed 79-19: Mar. 26, 2009. A yes vote is a +.

8. S Con Res 13. Fiscal 2010 Budget Resolution/Mortgage Relief.

Reed, D-R.I., amendment that would allow an increase in discretionary spending of Troubled Asset Relief Program funds to help save homes and small businesses; expand credit; and provide resources to government inspector. It would also expand congressional oversight. Adopted 56-42: Apr. 2, 2009. A yes vote is a +.

9. S Con Res 13. Fiscal 2010 Budget Resolution/Adoption.

Adoption of the budget that would set broad spending and revenue targets for the next five years. The resolution would fund to \$1.08 trillion in government discretionary spending for fiscal 2010. It would exempt from the targets legislated changes in health care and measures intended to address climate change. Adopted 55-43: Apr. 2, 2009. A yes vote is a +.

10. S Con Res 13. Fiscal 2010 Budget Resolution/Conference Report.

Adoption of conference report on the budget resolution that would fund up to \$1.086 trillion in non-emergency discretionary spending for fiscal 2010, \$764 billion in tax cuts, including \$130 billion for Iraq. An expected \$2 billion in savings, presumably from health care and student loan programs, will be used to create a deficit-neutral reserve fund for health care and climate change legislation. Adopted, thus cleared, 53-43. Apr. 29, 2009. A yes vote is a +.

11. S 896. Housing Loans Modification/'Cramdown' Provision.

Durbin, D-Ill., amendment that would allow bankruptcy judges to reduce the principal and interest rates of certain mortgages on primary homes, valued at less than

\$729,000. Rejected 45-51: Apr. 30, 2009. A yes vote is a +.

12. S 1390. Fiscal 2010 Defense Authorization/Cloture. Motion to invoke cloture on the Leahy (D-VT) amend-ment which would add the Matthew Shepard Hate Crimes Prevention Act of 2009. It would make it easier for Federal authorities to investigate and prosecute crimes of racial, ethnic, or religious violence, as well as sexual orientation, gender, gender identity, or disability. Motion agreed to 63-28: Jul. 16, 2009. A yes vote is a +.

13. Sotomayor Nomination/Confirmation. Confirmation of President Obama's nomination of Sonia Sotomayor of New York to be an associate justice of the U.S. Supreme Court. Confirmed 68-31: Aug. 6, 2009. A yes vote is a +.

14. HR 3326. Fiscal 2010 Defense Appropriations/Sexual Assault Arbitration Settlements. Franken, D-Minn., amendment that would prohibit the use of Federal Funds for contractors or subcontractors, who require mandatory arbitration of civil rights or sexual harassment claims as a condition of employment. Adopted 68-30: Oct. 6, 2009. A yes vote is a +.

15. HR 2996. Fiscal 2010 Interior-Environment Appropriations/Conference Report Point of Order. Feinstein, D-Calif., motion to waive the rules and appropriate funds for the Dept. of the Interior, the EPA and related agencies. In addition, it would provide continuing funding for agencies which had not yet received appropriations. Adopted 60-40: Oct. 29, 2009. A yes vote is a +.

16. HR 3548. Unemployment Benefits Extension/Cloture. Motion to invoke cloture (thus limiting debate) on the Baucus, D-Mont., amendment that would extend unemployment benefits by 14 weeks for those who had exhausted their 26 weeks

of state benefits, an additional 6 weeks to jobless individuals in high-unemployment states, and provide tax credits to first time home buyers. Motion agreed to 85-2: Nov. 2, 2009. A yes vote is a +.

17. HR 3590. Health Care Overhaul 'Shell' Bill/Cloture. Motion to invoke cloture (thus limiting debate) on the motion to proceed to the bill intended to serve as the vehicle for legislation that would overhaul the health care system. Motion agreed to 60-39: Nov. 21, 2009. A yes vote is a +.

18. HR 3590. Health Care Overhaul/ Abortion Funding Ban. Boxer, D-Calif., motion to table the Nelson, D-Neb., amendment which barred the use of federal funds to pay for abortion services or to cover any part of the costs of a health plan that includes abortion coverage. Insurance issuers would be allowed to offer separate supplemental coverage for abortions but it could not be paid for with federal subsidies. Motion agreed to 54-45: Dec. 8, 2009. A yes vote is a +.

19. HR 3590. Health Care Overhaul/ Prescription Drug Importation. Dorgan, D-N.D., amendment to the Reid, D-Nev., substitute amendment. The Dorgan amendment would have allowed registered importers to import prescription drugs into the United States and allowed individuals to purchase them for personal use. It would have established new registration and inspection requirements and required the Department of Health and Human Services to designate countries from which drugs can be imported. Rejected 51-48: Dec. 15, 2009. A yes vote is a +.

20. HR 3590. Health Care Overhaul/ Passage. Passage of the bill, as amended, that would overhaul the nation's health insurance system and require most individuals to buy health insurance by 2014. It would create a system of national private insurance plans supervised by the Office of Personnel Management and create state-run marketplaces for purchasing

health insurance. Employers with 50 or more workers would have to provide coverage or pay a fine if any employee gets a subsidized plan on the exchange. The bill would provide tax credits to certain small businesses for providing coverage and provide subsidies to qualified individuals, excluding illegal immigrants. It would bar use of federal funds to pay for abortions services in the new programs created under the bill, except in cases of rape, incest or if the woman's life is in danger. It would bar insurance companies from denying coverage based on pre-existing medical conditions beginning in 2014, and also bar them from dropping coverage of people who become ill. It would expand eligibility for Medicaid, shrink the coverage gap under the Medicare Part D prescription drug program and create an advisory board to reduce the per capita growth rate in Medicare spending. Passed 60-39: Dec. 24, 2009. A yes vote is a +.
