The ADA 2010 Voting Record: 111th Congress, 2nd Session

A YEAR OF ACCOMPLISHMENT AND FRUSTRATION

More notable accomplishments were achieved in the second session of the 111th Congress than in any session of the past 40 years. The new health care legislation overcame last-minute challenges to become law. Long-overdue regulations providing greater oversight of a financial system whose near collapse triggered the Great Recession were finally enacted. The armed forces were required to revoke the policy that forced LGBT Americans to hide their identity if they wanted to serve their country. And a treaty with Russia was ratified that will reduce the risk of nuclear war.

But 2010 was also a year of frustration – specifically with the United States Senate. An unprecedented abuse of Senate rules required every significant bill to receive a 60-vote supermajority for passage (or even consideration). Filibuster threats and secret holds not only abused the rules and defeated many worthy initiatives passed by the House – including campaign finance and immigration reform – but they also led to watering down legislation in the scramble to pick up the last few votes needed.

In an era of stubborn joblessness, the legislative battles over unemployment benefits were a continuing theme of the 111th Congress. In past periods of prolonged unemployment, Congress has extended unemployment compensation in order to alleviate personal hardship and maintain economic demand. Faced with the worst hiring environment in 70 years, a majority of Congress understood the need to continue that tradition. But conservatives who claimed to be concerned about the cost forced multiple votes, several short-

term extensions, and package deals that extended tax cuts for millionaires.

Among the most notable victims of Senate filibusters were the DISCLOSE Act and the DREAM Act. The DISCLOSE Act was intended to strengthen campaign finance laws in the wake of a destructive Supreme Court decision in *Citizens United v. FEC*, in which the Court allowed unlimited corporate spending on political campaigns. Among other things, the DISCLOSE Act would have revealed the hidden financial backers of television “issue ads.” It is interesting to note that, in the past, Republican opponents of limitations on campaign spending (notably Minority Leader Mitch McConnell of Kentucky) have argued that funds should not be limited, but instead should be disclosed. Yet, when offered such a bill, these same Republicans killed it.

The DREAM Act would have taken a sensible step towards humanizing and improving one part of our nation’s immigration laws. Undocumented, law-

abiding students who came to this country as children, finished high school and attended college or served honorably in the armed forces would have been placed on a path to citizenship. Both the DREAM Act and the DISCLOSE Act passed the House, but were stymied in the Senate, unable to muster the 60 votes needed to pass bills of any consequence. (The DISCLOSE Act fell three votes short in July, then failed by just one vote in September.)

It was only during the lame duck session that followed the midterm elections that the previously moribund Senate suddenly came to life, passing three significant measures within eight days: unemployment insurance extension paired with a tax-cut extension bill for the wealthy (opposed by ADA); repeal of the military’s discriminatory “Don’t Ask, Don’t Tell” policy that had forced gay and lesbian service members to hide their sexual identity; and the ratification of the New START nuclear weapons treaty with Russia. ADA proudly supported the repeal of “Don’t Ask, Don’t Tell” and

the New START treaty as meaningful legislation that would move our country forward. However, ADA strongly opposed the tax-cut extension bill since it extends the lower Bush-era tax rates for America's wealthiest and endangers the solvency of Social Security, even as cuts were planned in human needs programs to lower the federal deficit.

ADA's Congressional scorecard shows that the 111th Congress took a sharp rightward swing in the second year of the Obama Administration. In 2009, only one Senator (Republican Jim Bunning of Kentucky) earned an ADA "zero" by opposing the ADA position on every key vote. Last year, the number of Senate zeroes ballooned to 19 – nearly half of the Republican caucus. Conversely, 16 Senators in 2009 boasted a perfect ADA score of 100; in 2010, there were only five such Senate "heroes." While not quite as dramatic, the shift in the House was also pronounced: in 2009, 75 zeroes and 98 heroes; in 2010, 90 zeroes and 48 heroes.

The ultra-conservatism of the House Republican caucus is striking. Of the roughly 178 Republican members (the number varied slightly through the year as vacancies occurred), only three voted as much as a third of the time with ADA. Only nine voted the ADA position over

a fourth of the time, and only 13 House Republicans voted ADA's way on as many as one-fifth of the tracked votes. Overall, the House Republicans scored 5%, while their Democratic colleagues received an 84%. The Senate party averages were 7% for Republicans and 88% for Democrats.

Some political analysts believe, paradoxically, that the Democrats paid a political price in the midterm elections for their willingness and ability to get things done. They argue that the electorate saw

what was accomplished and disliked it. (Others believe that the party in power is historically blamed for high unemployment and tossed out.) The theory of "legislative overreach" is undermined by the fact that most of the high-ADA-scoring Democrats (the most enthusiastic backers of a progressive activist agenda) were reelected, whereas low-ADA-scoring "moderates" were not. Some of the difference can be explained by the electoral safety of more liberal districts, but not all.

Regardless of conservative rhetoric, and the deliberate misrepresentation of the legislation that was enacted, most voters do not want less government, they want more responsive government. Since its founding in 1947, ADA has been an advocate of responsive government: a government attuned to the needs and ambitions of all Americans, willing to offer support when and where private initiative and unfettered business leave these needs unmet. ADA's Congressional scorecard was created to discover and celebrate legislators who further that kind of government.

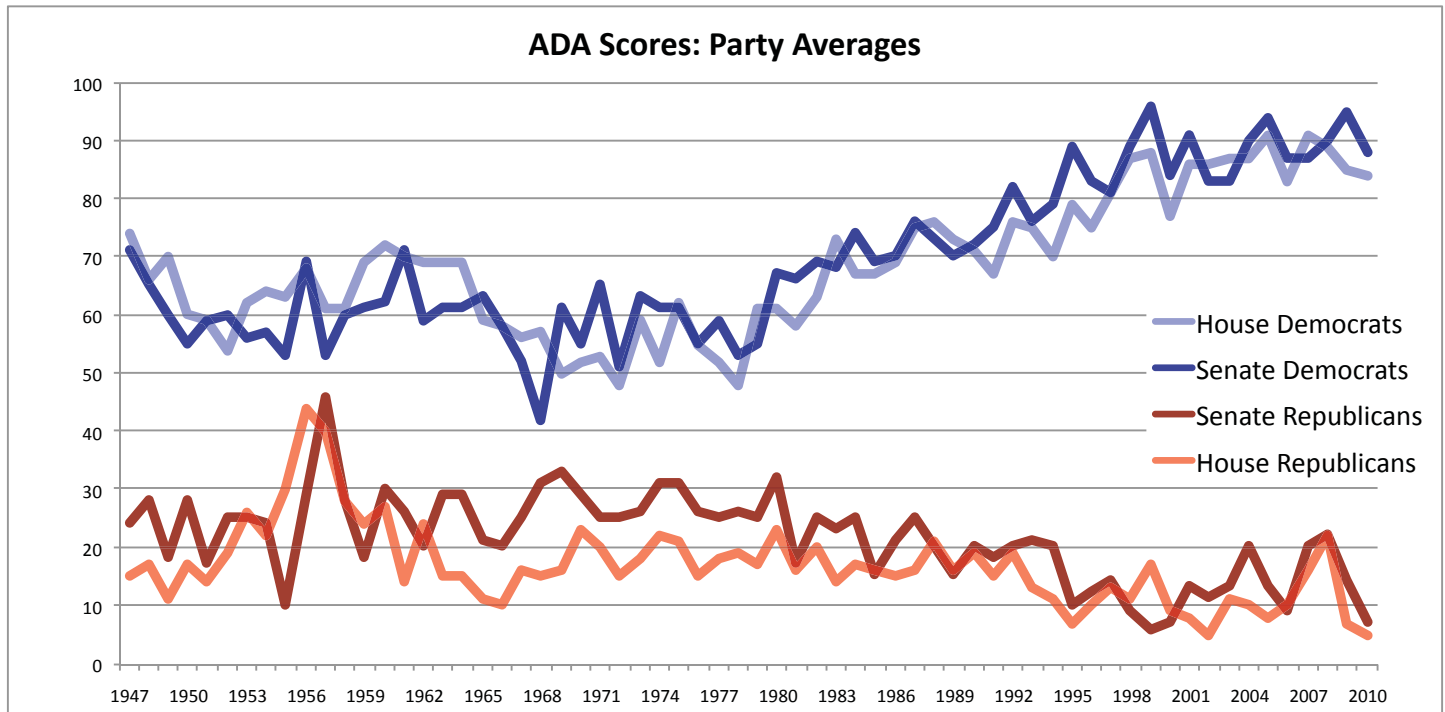

The Widening Divide

Bipartisan alliances on civil rights and a broad consensus on the role of government kept Democratic and Republican ratings close during the first half of the ADA scorecard's history. But 1980's Reagan Revolution accelerated a regional political realignment: Southern conservatives became Republicans, northern liberals, Democrats. The ideologically homogeneous parties that emerged are reflected in the diverging graph lines.



HOUSE VOTE DESCRIPTIONS

1. H.R. 3590 - Patient Protection and Affordable Care Act. Passage of the Senate health care reform bill as written. It facilitates coverage for 30 million uninsured Americans, curbs the worst insurance company abuses, and expands Medicare drug coverage, among other provisions. Passed 219-212: Mar. 21, 2010. A yes vote is a +.

2. H.R. 4872 - Health Care and Education Reconciliation Act of 2010. Adjustments to the health care reform bill passed by the Senate in 2009 and then passed in identical form by the House on the understanding that differences would be worked out through this mechanism. This bill also improves the college student-loan system. Passed 220-207: Mar. 25, 2010. A yes vote is a +.

3. H. Amendment 672 to H.R. 5136 - National Defense Authorization Act for Fiscal Year 2011. Amendment to a military funding bill that would allow all members of the U.S. military to serve without hiding their sexual orientation. Passed 234-194:

May 27, 2010. A yes vote is a +.

4. H.R. 4213 - Unemployment Compensation Extension Act of 2010. Legislation to extend through November 30 long-term unemployment insurance benefits otherwise set to expire. Passed 215-204: May 28, 2010. A yes vote is a +.

5. H.Res. 989 - A resolution requiring the United States to adopt national policies and pursue international agreements which would prevent ocean acidification. Failed under suspension rules requiring two-thirds majority. 241-170: June 9, 2010. A yes vote is a +.

6. H.R. 5175 - Democracy is Strengthened by Casting Light on Spending in Elections (DISCLOSE) Act. Passage of the bill that would require outside organizations engaged in political campaigns to provide more information about their funding sources. Passed 219-206: June 24, 2010. A yes vote is a +.

7. H.R. 5618 - Restoration of Emergency Unemployment Compensation Act. Made necessary by the failure of the Senate to act earlier, this second attempt would extend benefits through November 30, 2010. In the absence of an extension, benefits for the unemployed were running out at a rate of about 200,000 per week. Failed under suspension rules requiring two-thirds majority, 261-155: June 29, 2010. A yes vote is a +.

8. H.R. 4173 - Dodd-Frank Wall Street Reform and Consumer Protection Act. Legislation to better regulate Wall Street firms and products, create a Consumer Financial Protection Bureau, and make other necessary reforms in response to the financial crisis of 2008. Passed 237-192: June 3, 2010. A yes vote is a +.

9. H. Amendment 5 (McGovern-Obey Amendment) to H.R. 4899 - Disaster Relief and Summer Jobs Act of 2010.

Amendment to require the president to set a timeline for withdrawal of U.S. troops from Afghanistan and increase oversight of private contractors. It would mandate another Congressional vote in 2011 if President Obama did not follow through with plans to begin withdrawal in July 2011. Failed 162-260: July 1, 2010. A yes vote is a +.

10. H.R. 4213 - Unemployment Compensation Extension Act. Vote to extend unemployment and health insurance benefits through the end of the year. It also would preserve the current rates of Medicare payments to doctors – otherwise scheduled to be reduced, and would continue dozens of targeted tax reductions. Passed 272-152: July 22, 2010. A yes vote is a +.

11. H.R. 847 - James Zadroga 9/11 Health and Compensation Act of 2010. Legislation to provide aid to responders, or the survivors of such responders, who suffered long-term health affects from their exposure to the 9/11 terrorist attack sites. Failed under suspension rules requiring two-thirds majority, 255-159: July 29, 2010. A yes vote is a +.

12. H.R. 3534 - Consolidated Land, Energy, and Aquatic Resources (CLEAR) Act of 2010. A bill to remove the existing \$75 million liability cap on marine oil spills, raise safety standards for drilling equipment, and strengthen government regulation of off-shore drilling. Passed 209-193: July 3, 2010. A yes vote is a +.

13. H.R. 1586 - Medicaid, Jobs and Education Assistance Act. Bill to provide \$26 billion to the states: \$16 billion to extend Medicaid's temporary enhanced

Federal Medical Assistance Percentage (FMAP) for six months, and \$10 billion for education funding to forestall teacher layoffs. Passed 247-161: Aug. 1, 2010. A yes vote is a +.

14. H.R. 4785 - Rural Energy Savings Program Act. Would have provided loans to rural consumers to implement energy efficiency measures. Passed 240-172: Sept. 16, 2010. A yes vote is a +.

15. H.R. 3082 - Continuing Resolution. Would have funded federal agencies through the remainder of fiscal year 2011 (ending September 30, 2011) at fiscal year 2010 levels. Passed 212-206: Dec. 8, 2010. A yes vote is a +.

16. H.R. 5281 - Development, Relief, and Education for Alien Minors (DREAM) Act of 2010. Legislation to provide a pathway to citizenship for undocumented immigrants brought to this country as minors, who subsequently maintained a clean criminal record, graduated from high school, and attended college or served in the military. Passed 216-198: Dec. 8, 2010. A yes vote is a +.

17. H.R. 2965 - Dont Ask, Dont Tell Repeal Act of 2010. After an earlier amendment to achieve the same result failed in the Senate, a stand-alone bill to allow all members of the military to serve without hiding their sexual orientation. Passed 250-175: Dec. 15, 2010. A yes vote is a +.

18. H. Amendment 786 (Pomeroy Amendment) to H.R. 4853 - Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act

of 2010. Amendment to the unemployment and tax-cut extension bill that would lower the amount excluded from estate tax to \$3.5 million. Failed 194-233: Dec. 16, 2010. A yes vote is a +.

19. H.R. 4853 - Tax Relief, Unemployment Insurance Reauthorization and Job Creation Act of 2010. Legislation to extend for an additional two years the 2001 and 2003 income tax cuts otherwise slated to expire, extend long-term unemployment compensation for 13 months, temporarily reduce the payroll tax (thereby undermining the solvency of Social Security), and establish an estate tax with a \$5 million exclusion. Passed 277-148: Dec. 16, 2010. A no vote is a +.

20. H.R. 2751 - FDA Food Safety Modernization Act. Vote to allow the Food and Drug Administration to directly recall tainted products, rather than rely on manufacturers' voluntary cooperation. Passed 215-144: Dec. 21, 2010. A yes vote is a +.

A Note on the Voting Record

The ADA Congressional Voting Record offers a uniquely comprehensive guide to legislative ideology, covering as it does a broad range of issues – economic, social, domestic, international. Like all voting records, however, it is not intended to judge the effectiveness of legislators. It does not reflect all the effort that comes before and after floor votes: drafting legislation, soliciting support of colleagues, working in committee, overseeing execution of new laws. But it is a good gauge of political belief, which is, after all, the basis of political action.

SENATE VOTE DESCRIPTIONS

1. P.N. 1351 - Confirming Paul Becker as a member of the National Labor Relations Board. Vote to confirm nomination of Paul Becker, a former staffer for the AFL-CIO and SEIU, to a body meant to fairly oversee employer-employee relations. Rejected 33-52: Feb. 9, 2010. A yes vote is a +.

2. H.R. 4872 - Health Care and Education Reconciliation Act of 2010. Proposed adjustments to the health care reform bill passed by the Senate in 2009 and then passed in identical form by the House earlier in 2010 on the understanding that differences would be worked out through this mechanism. The bill also improves the college student-loan system. Passed 56-43: Mar. 25, 2010. A yes vote is a +.

3. H.R. 4851 - Continuing Extension Act of 2010. Legislation to restore and extend long-term unemployment insurance benefits through June 2, 2010, that were in danger of expiring. Passed 59-38: Apr. 15, 2010. A yes vote is a +.

4. H.R. 4173 - Dodd-Frank Wall Street Reform and Consumer Protection Act. A bill to increase regulation of Wall Street firms and products, create a Consumer Financial Protection Bureau, and make other necessary reforms in response to the financial crisis of 2008. Passed 59-39: May 2, 2010. A yes vote is a +.

5. Amendment 4204 (Feingold Amendment) to H.R. 4899 - Disaster Relief and Summer Jobs Act of 2010. Legislation that would require the President to present by the end of the year a timetable for withdrawal of American troops from Afghanistan. Rejected: 18-80: May 27, 2010. A yes vote is a +.

6. S.J. Res. 26 (Murkowski Amendment). A measure to curb the Environmental Protection Agency's authority to regulate greenhouse gas emissions from factories,

power plants and other large polluters. Rejected 47-53: June 1, 2010. A no vote is a +.

7. Amendment 4318 (Sanders Amendment) to H.R. 4213 - Unemployment Compensation Extension Act. Legislation that would repeal \$35 billion in oil and gas industry tax breaks and devote \$25 billion of the savings to deficit reduction. The remaining \$10 billion would fund an Energy Efficiency Conservation Block Grant Program. Rejected 35-61: June 15, 2010. A yes vote is a +.

8. H.R. 4213 - Unemployment Compensation Extension Act. Vote to extend through November 30, 2010, the long-term unemployment insurance benefits that were otherwise set to expire. Failed cloture vote 58-38: June 3, 2010. A yes vote is a +.

9. S. 3628 - Democracy is Strengthened by Casting Light on Spending in Elections (DISCLOSE) Act. Legislation to require outside organizations engaged in partisan political campaigns to provide more information about their funding sources. Failed cloture vote 57-41: July 27, 2010. A yes vote is a +.

10. H.R. 1586 - Medicaid, Jobs and Education Assistance Act. Legislation to provide \$26 billion to the states: \$16 billion to extend Medicaid's temporary enhanced Federal Medical Assistance Percentage (FMAP) for six months, and \$10 billion for education funding to forestall teacher layoffs. Passed, 61-38: Aug. 4, 2010. A yes vote is a +.

11. P.N. 1768 - Confirming Elena Kagan as Associate Justice of the Supreme Court. Vote to confirm nomination of Elena Kagan as the fourth sitting justice named to the High Court by a Democratic president. She replaced John Paul Stevens who, though

picked by Republican President Gerald Ford, had become the leader of the liberal bloc. Passed 63-37: Aug. 5, 2010. A yes vote is a +.

12. S. 3628 - Democracy is Strengthened by Casting Light on Spending in Elections (DISCLOSE) Act. Second vote on legislation that would require outside organizations engaged in partisan political campaigns to provide more information about their funding sources. Failed cloture vote 59-39: Sept. 23, 2010. A yes vote is a +.

13. S. 3772 - Paycheck Fairness Act. Vote to amend the existing Fair Pay Act by requiring employers to allow their employees to share salary information with each other for purposes of rooting out gender discrimination. Failed cloture vote 58-41: Nov. 17, 2010. A yes vote is a +.

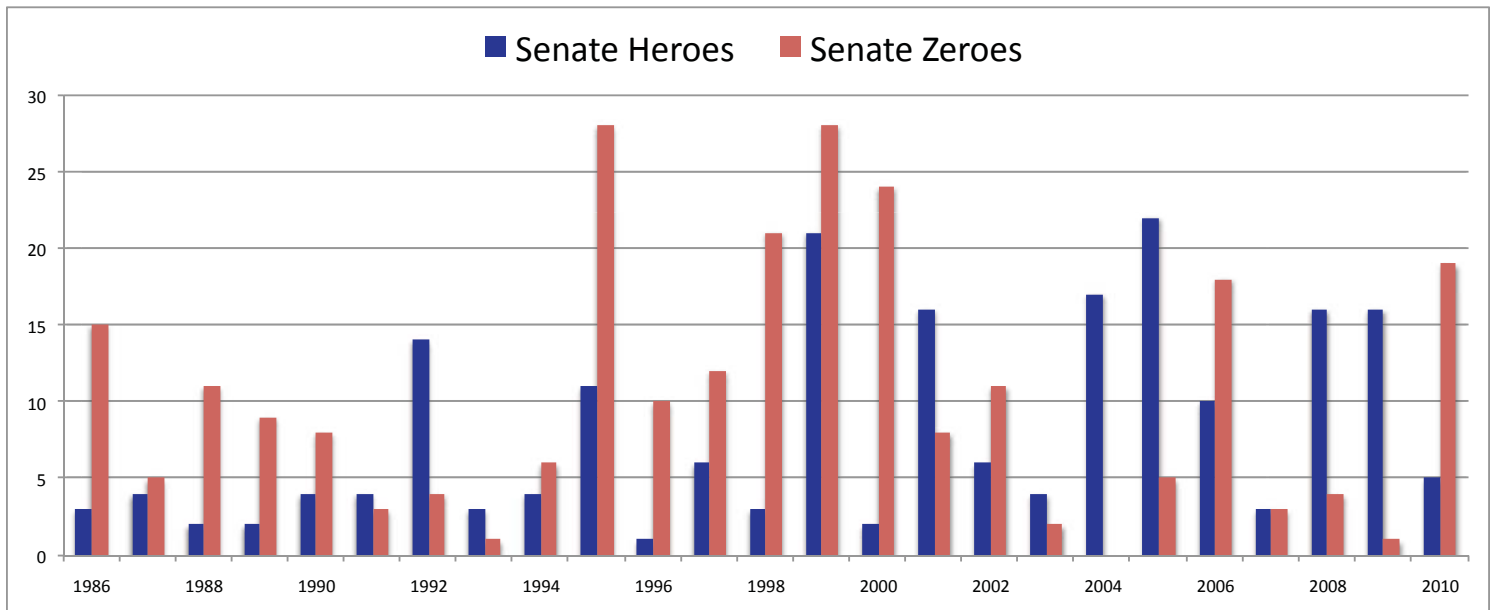
14. H.R. 2751 - FDA Food Safety Modernization Act. Legislation to allow the Food and Drug Administration to directly recall tainted products, rather than rely on manufacturers' voluntary cooperation. Passed 73-25: Nov. 3, 2010. A yes vote is a +.

15. H.R. 847 - James Zadroga 9/11 Health and Compensation Act of 2010. Legislation to provide aid to responders, or the survivors of such responders, who suffered long-term health effects from their exposure to the 9/11 terrorist attack sites. Failed cloture vote; bill later passed on an unrecorded voice vote. Rejected 57-42: Dec. 9, 2010. A yes vote is a +.

16. H.R. 4853 - Tax Relief, Unemployment Insurance Reauthorization and Job Creation Act of 2010. Legislation to extend for an additional two years the 2001 and 2003 income tax cuts otherwise slated to expire, extend long-term unemployment compensation for 13 months, temporarily reduce the payroll tax (thereby undermining the solvency of Social Security), and

Heroes & Zeroes: Charting the Extremes of the Senate

The extremes of the ADA scores tend not to move in easily explained patterns. Sometimes the number of Heroes (100% correct votes) or Zeroes (no correct votes) even move in the opposite direction as the party averages: an election might remove moderates from the caucus while at the same time strengthening the resolve of the remaining liberals or conservatives.

17. H.R. 5281-Development, Relief and Education for Alien Minors (DREAM) Act of 2010. Legislation to provide a pathway to citizenship for undocumented immigrants brought to this country as minors, who subsequently maintained a clean criminal record, graduated from high school, and attended college or served in the military. Failed cloture vote 55-41: Dec. 18, 2010. A yes vote is a +.

18. H.R. 2965 - Don't Ask, Don't Tell Repeal Act of 2010. A vote to allow all members of the U.S. military to serve without hiding their sexual orientation. Passed 63-33: Dec. 18, 2010. A yes vote is a +.

19. Amendment No. 4814 (McCain Amendment) to Treaty Doc. 111-5 - To amend the preamble to strike language regarding the interrelationship between

strategic offensive arms and strategic defensive arms. Amendment to require the complete renegotiation of a nuclear treaty with Russia because of nonbinding language in the pact's preamble. Rejected 37-59: Dec. 18, 2010. A no vote is a +.

20. Treaty Doc. 111-5 - Strategic Arms Reduction Treaty Vote for a nuclear arms

treaty with Russia that will reduce the number of warheads in both U.S. and Russian arsenals and reinstitute mutual inspections, while allowing for modernization of nuclear stockpiles and development of antiballistic defenses. Passed 71-26: Dec. 22, 2010. A yes vote is a +.
